### 3. Why are ELGA releasing new software?

Due to part obsolescence, the graphics display has changed. The replacement display, displays upside down, so the software update simply rectifies this issue. Please note that all existing installations will not be affected if v1.4.1 is installed.

## 5. Where can I get the new Software from?

Software can be downloaded from the PartnerNet. There are two different software files which contain different language sets;

1. Western: English, French, German, Italian, Spanish & Portuguese.
2. Eastern: English, Japanese and Mandarin.

If you experience difficulty downloading the software onto your USB Mass Storage Device, please contact the ELGA Technical Support Team.

**Important Note: - Please do not download PURELAB Chorus software onto the same USB as PURELAB flex software as the systems cannot differentiate between the two UPDATE.ENC files.**

## 6. When should I upload the new flex software on my customer's system?

ELGA recommend downloading the latest version of software on your customers system during routine service visits, after commissioning or system upgrades.

Updating software can take up to 10 minutes to complete and the status of the update will be displayed on the handset display.
